DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On November 10, 2014, the parties filed a stipulation of fact in which they agreed on an appropriate amount for attorneys' fees and costs in this case.

Petitioner submitted her request for attorneys' fees and costs to respondent. After informal discussions, petitioner amends her application for attorneys' fees and costs to \$23,755.03. This amount includes fees for both petitioner's current counsel, Richard H. Moeller, and petitioner's former counsel, Sherry Kay Drew. In accordance with the General Order #9

requirement, petitioner asserts that she advanced \$1,352.66 in costs in pursuit of her petition. Respondent does not object to these amounts. The undersigned finds these amounts to be reasonable. Accordingly, the court awards:

- a. \$23,755.03, representing reimbursement for attorneys' fees and costs. The award shall be in the form of a check payable jointly to petitioner and Berenstein, Moore, Heffernan, Moeller & Johnson, L.L.P. in the amount of \$23,755.03; and
- b. \$1,352.66, representing reimbursement for petitioner's costs. The award shall be in the form of a check payable to petitioner in the amount of \$1,352.66.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²

IT IS SO ORDERED.
