## **DECISION<sup>1</sup> (ATTORNEYS' FEES AND COSTS)**

In this case under the National Vaccine Injury Compensation Program,<sup>2</sup> I issued a decision on January 29, 2013, awarding interim attorneys' fees and costs for all work performed before January 14, 2013. On April 8, 2014, I issued a decision denying Petitioners' eligibility for an award of compensation.

On April 24, 2014, the parties filed a Stipulation of Facts Concerning Attorneys' Fees and Costs, which addressed expenses that Petitioners incurred after January 14, 2013. The parties' Stipulation requests an additional payment of \$10,848.00, representing all of the remaining attorneys' fees and costs that are available under 42 U.S.C. § 300aa-15(e).

A final award for fees and costs is appropriate at this time. Further, the proposed amount seems reasonable and appropriate. Accordingly, I hereby award the following attorneys' fees and costs, pursuant to 42 U.S.C. § 300aa-15(b) and (e)(1):

• a lump sum of \$10,848.00, in the form of a check payable jointly to petitioners and petitioners' counsel, Larry G. Michel, on account of services performed by counsel's law firm.

In the absence of a timely-filed motion for review filed pursuant to Appendix B of the Rules of the U.S. Court of Federal Claims, the clerk of the court shall enter judgment in accordance herewith.<sup>3</sup>
