DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On January 11, 2016, the parties filed a stipulation of fact in which they agreed on an appropriate amount for attorneys' fees and costs in this case. In accordance with the General Order #9 requirement, petitioners filed a statement on January 11, 2016, asserting that they did not incur any costs in pursuit of their petition.

Petitioners submitted their request for attorneys' fees and costs to respondent. During informal discussions, respondent raised objections to certain items in petitioners' application. Based on these objections, petitioners amend their application for attorneys' fees and costs to

\$91,338.08. Respondent does not object to this amount. The undersigned finds this amount to be reasonable. Accordingly, the court awards \$91,338.08, representing reimbursement for attorneys' fees and costs. The award shall be in the form of a check payable jointly to petitioners and Ragsdale, L.L.C. in the amount of \$91,338.08.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²
