ATTORNEY'S FEES AND COSTS DECISION¹

On October 29, 2010, Ms. Loretta Floyd ("petitioner") filed a petition pursuant to the National Vaccine Injury Compensation Program.² 42 U.S.C. §§ 300aa-1 to -34 (2006). Petitioner alleged that she suffered from neurologic, rheumatologic, and gastrointestinal injuries as a result of a measles, mumps, rubella (MMR) vaccination she received on October 10, 2007. Petition at Preamble. On March 20, 2014, a decision dismissing the petition for insufficient proof was entered.

On May 27, 2014, the parties filed a Joint Stipulation on Fees and Costs. According to

the stipulation, the parties stipulate to an award to petitioner of attorney's fees and costs in the amount of \$11,614.38. In accordance with General Order #9, petitioner's counsel represents that petitioner advanced \$350.00, in litigation costs in pursuing her petition.

The Vaccine Act permits an award of reasonable attorney's fees and costs. 42 U.S.C. § 300 aa-15(e). Based on the reasonableness of the parties' stipulation, the undersigned **GRANTS** the request for approval and payment of attorney's fees and costs.

Accordingly, an award should be made as follows:

- (1) in the form of a check jointly payable to petitioner and Richard Gage, of Richard Gage, P.C., in the amount of **\$11,614.38**, and
- (2) in the form of a check payable to petitioner only in the amount of **\$350.00**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court **SHALL ENTER JUDGMENT** in accordance with the terms of the parties' stipulation.³

IT IS SO ORDERED.
