## **DECISION**<sup>1</sup> (ATTORNEY FEES AND COSTS)

In this case under the National Vaccine Injury Compensation Program,<sup>2</sup> Special Master Zane issued a Decision on August 30, 2013. On January 16, 2014, the parties filed a stipulation concerning attorney's fees and costs in this matter. The parties' stipulation requests a total payment of \$9, 271.74, representing attorney's fees and costs. In accordance with General Order #9, Petitioner's counsel noted that Petitioner incurred \$161.31 in litigation costs out of this total amount.

The undersigned finds that this petition was brought in good faith and that there exists a reasonable basis for the claim. Therefore, an award for fees and costs is appropriate, pursuant to 42 U.S.C. § 300aa-15(b) and (e)(1). The undersigned finds said stipulation reasonable and adopts it as the decision of the Court in awarding attorneys' fees and costs, on the terms set forth therein.

I hereby award a lump sum of \$9,110.43, in the form of a check payable jointly to Petitioner and Petitioner's counsel, Katherine M. Gonyea, Esq. I additionally award the amount of \$161.31, in the form of a check made payable to Petitioner.

In the absence of a timely-filed motion for review filed pursuant to Appendix B of the Rules of the U.S. Court of Federal Claims, the clerk of the court shall enter judgment in accordance herewith.
