DECISION ON ATTORNEY FEES AND COSTS¹

Gowen, Special Master:

In this case under the National Vaccine Injury Compensation Program,² I issued a decision on April 30, 2015, adopting the parties' stipulation and finding the petitioner was entitled to compensation. On August 24, 2015, the parties filed a Stipulation of Fact concerning attorneys' fees and costs. Additionally, pursuant to General Order #9, petitioner's counsel asserted that petitioner incurred no personal litigation costs in this matter. Id. at para. 3.

The parties' stipulation indicates that respondent does not object to the amount of \$57,287.82 in attorneys' fees and cost that petitioner is requesting.

I find that this petition was brought in good faith and that there existed a reasonable basis for the claim. Therefore, an award for fees and costs is appropriate, pursuant to 42 U.S.C. §§ 300aa-15(b) and (e)(1). Further, the proposed amount seems reasonable and appropriate. **Accordingly, I hereby award:**

- **A lump sum of \$57,287.82 in the form of a check payable jointly to petitioner and petitioner's counsel of record, Isaiah Kalinowski, Esq. for petitioner's attorney fees and costs.**

The clerk of the court shall enter judgment in accordance herewith.³
