DECISION ON ATTORNEY FEES AND COSTS¹

Gowen, Special Master:

In this case under the National Vaccine Injury Compensation Program, ² I issued a fact ruling and dismissal decision on July 2, 2014. On February 8, 2015, the parties filed a Stipulation of Fact concerning attorneys' fees and costs. Additionally, pursuant to General Order #9, petitioner's counsel asserted that petitioner did not personally incur litigation costs in this matter. <u>Id.</u> at para. 4.

The parties' stipulation indicates that respondent does not object to the amended amount of \$45,000.00 that petitioner is requesting for attorneys' fees and costs.

I find that this petition was brought in good faith and that there existed a reasonable basis for the claim. Therefore, an award for fees and costs is appropriate, pursuant to 42 U.S.C. §§ 300aa-15(b) and (e)(1). Further, the proposed amount seems

reasonable and appropriate. Accordingly, I hereby award:

 a lump sum of \$45,000.00 in the form of a check payable jointly to petitioner and petitioner's attorney, Firooz T. Namei, of McKinney & Namei Co., LPA, for petitioner's attorneys' fees and costs.

The clerk of the court shall enter judgment in accordance herewith.³
