DECISION ON ATTORNEY FEES AND COSTS¹

Gowen, Special Master:

In this case under the National Vaccine Injury Compensation Program,² I issued a Decision on June 12, 2014, denying compensation. On September 17, 2014, the parties filed a Stipulation of Fact concerning attorneys' fees and costs. Pursuant to General Order #9, petitioner also filed on September 17, 2014, a statement indicating that he did not incur costs related to the litigation of this matter.

The parties' stipulation indicates that respondent does not object to the amended amount of \$33,690.80 that petitioner is requesting for attorneys' fees and costs.

I find that this petition was brought in good faith and that there existed a reasonable basis for the claim. Therefore, an award for fees and costs is appropriate, pursuant to 42 U.S.C. §§ 300aa-15(b) and (e)(1). Further, the proposed amount seems

reasonable and appropriate. Accordingly, I hereby award:

• a lump sum of \$33,690.80 in the form of a check payable jointly to petitioner and petitioner's attorney, Danielle A. Strait, for petitioner's attorneys' fees and costs.

The clerk of the court shall enter judgment in accordance herewith.³
