DECISION ON ATTORNEYS' FEES AND COSTS¹

On February 7, 2013, Audrey Hodle ("petitioner") filed a petition pursuant to the National Vaccine Injury Compensation Program.² 42 U.S.C. §§ 300aa-1 to -34 (2012). Petitioner alleged that as a result of receiving a Tetanus-diptheria-acellular-pertussis ("Tdap") vaccine on or about February 16, 2011, she suffered Guillain-Barre Syndrome. Petition at Preamble. On September 11, 2015, the parties filed a stipulation in which they agreed to an award of compensation to petitioner. On that same day, the undersigned issued a decision adopting the parties' stipulation for an award.

On October 15, 2015, the parties filed a stipulation concerning attorneys' fees and costs. Petitioner requests a total award of attorneys' fees and costs in the amount of \$75,000.00. Stip. for Fees and Costs \P 5. Respondent does not object. <u>Id.</u> at \P 4. In accordance with General Order #9, petitioner represents that she did not incur any reimbursable costs in pursuit of this claim. <u>Id.</u>

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300 aa-15(e). Based on the reasonableness of the parties' stipulation, the undersigned **GRANTS** the request for approval and payment of attorneys' fees and costs.

Accordingly, an award should be made as follows:

(1) in the form of a check jointly payable to petitioner and to petitioner's attorney, Lawrence R. Cohan, of Anapol, Schwartz, et al., in the amount of \$75,000.00.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court **SHALL ENTER JUDGMENT** in accordance herewith.³

IT IS SO ORDERED.
