ATTORNEYS' FEES AND COSTS DECISION 1

On February 20, 2013, Sandra Vasquez ("petitioner") filed a petition for compensation under the National Vaccine Injury Compensation Program ("Vaccine Program")² alleging that she received the human papillomavirus on August 17, 2010 in Upland, Pennsylvania and suffered shortly thereafter vaccine induced autoimmune hepatitis. On July 10, 2014, a decision awarding compensation to petitioner based on the parties' stipulation was entered.

All citations in this decision to individual sections of the Act are to 42 U.S.C.A. § 300aa.

On September 5, 2014, the parties filed a Stipulation of Fact Concerning Attorneys' Fees and Costs. According to the stipulation, respondent does not object to a total award of attorneys' fees and costs in the amount of \$24,000.00. In accordance with General Order #9, petitioner filed a statement stating that she incurred no out-of-pocket expenses in pursuing her petition.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300 aa-15(e). Based on the reasonableness of petitioner's request and respondent's counsel's lack of objection to petitioner's counsel's fee request, the undersigned **GRANTS** petitioner's motion for approval and payment of attorneys' fees and costs.

Accordingly, an award should be made as follows:

in the form of a check jointly payable to petitioner and the law firm of Mark T. Sadaka, LLC in the amount of **\$24,000.00**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court **SHALL ENTER JUDGMENT** in accordance with the terms of the parties' stipulation.³

IT IS SO ORDERED.
