DECISION¹

On May 22, 2013, Cristal Bello ("Petitioner") filed a petition for compensation under the National Childhood Vaccine Injury Act of 1986, 42 U.S.C. §§ 300aa-1 *et seq.* (2006) ("Vaccine Act"). Petitioner alleged that the administration of a Human Papillomavirus ("HPV") vaccine on June 4, 2010 caused her to suffer from premature ovarian failure.

On November 24, 2015, the parties filed a Stipulation of Fact Concerning Petitioner's Costs. Pursuant to their stipulation, the parties have agreed to an award of \$1,015.47 for costs incurred personally by Petitioner.

The undersigned finds that an award for costs is appropriate pursuant to 42 U.S.C. § 300aa-15(b) and (e)(1). Further, the proposed amount seems reasonable and appropriate. **Accordingly, the undersigned hereby awards the amount of \$1,015.47, in the form of a check made payable solely to Petitioner, Cristal Bello.**

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of
