DECISION¹

On December 1, 2014, the parties filed a stipulation of fact in which they agreed on an appropriate amount for attorneys' fees and costs in this case.

Petitioner filed his Attorneys' Fees and Costs Application on November 14, 2014. During informal discussions, respondent raised objections to certain items in petitioner's application. Based on these objections, petitioner amends his application to reflect an amount for

attorneys' fees and costs of \$18,000.00. In addition, petitioner requests reimbursement for \$400.00 in personal costs. Respondent does not object to these amounts. The undersigned finds these amounts to be reasonable. Accordingly, the undersigned awards:

\$18,000.00, representing reimbursement for attorneys' fees and costs. The award shall be in the form of a check made payable jointly to petitioner and Paul S. Dannenberg, Esq., in the amount of \$18,000.00, and

\$400.00, representing reimbursement for personal costs for petitioner Michael Berglund. The award shall be in the form of a check made payable to Michael Berglund in the amount of \$400.00.

In the absence of a motion for review filed pursuant to RCFC, Appendix B, the clerk of the court is directed to enter judgment herewith.²
