DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On March 23, 2015, the parties filed a stipulation of fact in which they agreed on an appropriate amount for attorneys' fees and costs in this case.

Petitioner filed an application for attorneys' fees and costs on February 19, 2015, seeking \$19,977.08 in reimbursement for attorneys' fees and costs. During informal discussions, respondent raised objections to certain items in petitioner's application. Based on these objections, petitioner amends her application to request \$19,000.00, consisting of \$18,347.25 in

attorneys' fees and costs and \$652.75 in petitioner's costs. Respondent does not object to this amount. The undersigned finds this amount to be reasonable. Accordingly, the court awards:

- a. **\$18,347.25**, representing reimbursement for attorneys' fees and costs. The award shall be in the form of a check payable jointly to petitioner and Conway, Homer & Chin-Caplan, P.C. in the amount of **\$18,347.25**; and
- b. **\$652.75**, representing reimbursement for petitioner's costs. The award shall be in the form of a check payable to petitioner in the amount of **\$652.75**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²

IT IS SO ORDERED.
