DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On April 6, 2015, the parties filed a stipulation of fact in which they agreed on an appropriate amount for attorneys' fees and costs in this case.

Petitioner filed his application for attorneys' fees and costs on March 5, 2015. During informal discussions, respondent raised objections to certain items in petitioner's application. Based on these discussions, petitioner amends his application for attorneys' fees and costs to request \$12,900.00 in attorneys' fees and costs and \$350.00 in petitioner's costs. Respondent

does not object to these amounts. The undersigned finds these amounts to be reasonable. Accordingly, the court awards:

- a. \$12,900.00, representing reimbursement for attorneys' fees and costs. The award shall be in the form of a check payable jointly to petitioner and Conway, Homer & Chin-Caplan, P.C. for \$12,900.00; and
- b. \$350.00, representing reimbursement for petitioner's costs. The award shall be in the form of a check payable to petitioner for \$350.00.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²

IT IS SO ORDERED.
