ATTORNEYS' FEES AND COSTS DECISION¹

On September 10, 2013, Thomas Weil ("petitioner") filed a petition pursuant to the National Vaccine Injury Compensation Program.² 42 U.S.C. §§ 300aa-1 to -34 (2006). Petitioner alleged that she developed Guillain-Barré Syndrome ("GBS") as a result of receiving an influenza (flu) vaccine on October 30, 2012. See Petition at 1-2. On April 24, 2014, a decision was entered based on the parties' stipulation awarding compensation to petitioner.

On October 27, 2014, petitioner filed an application for attorney's fees and costs

requesting a total award to petitioner of attorneys' fees and costs in the amount of \$7,610.13. In accordance with General Order #9, petitioner's counsel represents that petitioner did not personally advance any reimbursable costs in pursuit of his claim. On October 28, 2014, counsel for respondent contacted the court via e-mail to state that respondent would not be filing an objection to petitioner's attorney's fee and cost application and that respondent agrees that the amount requested is not unreasonable. See Informal Communication docketed Oct. 29, 2014.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300 aa-15(e). Based on the reasonableness of petitioner's application and respondent's lack of objection, the undersigned **GRANTS** the request for approval and payment of attorneys' fees and costs.

Accordingly, an award should be made as follows:

in the form of a check jointly payable to petitioner and to petitioner's attorney, Sherry K. Drew, of McDowell & Drew, Ltd., in the amount of **\$7,610.13**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court **SHALL ENTER JUDGMENT** in accordance with the terms of the parties' stipulation.³

IT IS SO ORDERED.
