DECISION ON JOINT STIPULATION¹

Roth, Special Master:

Joan Karl ["petitioner"] filed a petition for compensation under the National Vaccine Injury Compensation Program² on January 16, 2014. Petitioner alleges that she developed significant tachycardia, inappropriate sinus tachycardia, non-specific ST abnormalities³ and palpitations an influenza ("flu") vaccination on January 6, 2012. *See* Petition, at 1. Respondent denies that the influenza vaccine caused petitioner to suffer any injury and that her current disabilities are a sequela of the vaccine-related injury. Stipulation at 1.

Nevertheless, the parties have agreed to settle the case. On April 21, 2016, the parties filed a joint stipulation agreeing to settle this case and describing the settlement terms.

Respondent agrees to issue the following payment:

A lump sum of \$40,000.00 in the form of a check payable to petitioner, Joan Karl. This amount represents compensation for all damages that would be available under § 300aa-15(a).

I adopt the parties' stipulation attached hereto, and award compensation in the amount and on the terms set forth therein. The clerk of the court is directed to enter judgment in accordance with this decision.⁴
