DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On August 4, 2014, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleged that she suffered a shoulder injury related to vaccine administration ("SIRVA") following receipt of her January 11, 2014 Tetanus Diphtheria toxoid ("Td") vaccination. On December 29, 2015, the undersigned issued a decision awarding compensation to petitioner based on the parties' stipulation. (ECF No. 34).

On March 24, 2016, petitioner filed an unopposed motion for attorneys' fees and costs. (ECF No. 38).³ Petitioner requests attorneys' fees and costs in the amount of

\$22,000.00. *Id.* at 1. In compliance with General Order #9, petitioner has filed a signed statement indicating petitioner incurred no out-of-pocket expenses. (ECF No. 39.)

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$22,000.00⁴ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Amber Wilson, Esq.⁵

The clerk of the court shall enter judgment in accordance herewith.⁶
