## ATTORNEYS' FEES AND COSTS DECISION1

On September 8, 2014, Patricia Beltran ("petitioner"), filed a petition pursuant to the National Vaccine Injury Compensation Program.<sup>2</sup> 42 U.S.C. §§ 300aa-1 to -34 (2006). Petitioner alleged that as a result of receiving the Influenza (Flu) vaccine on November 23, 2013, she suffered a shoulder injury. Petition at 1. On February 10, 2015, the undersigned entered a decision awarding compensation to petitioner based on a stipulation filed by the parties.

On September 2, 2015, the parties filed a Stipulation of Facts Regarding Final Attorney's Fees and Costs. According to the stipulation, the parties stipulate to a total award to petitioner of

attorneys' fees and costs in the amount of \$15,250.00. In accordance with General Order #9, petitioner's counsel states that petitioner did not advance any reimbursable costs in pursuit of this claim.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300 aa-15(e). Based on the reasonableness of petitioner's request and the lack of any objection by respondent, the undersigned **GRANTS** the request for approval and payment of attorneys' fees and costs.

Accordingly, an award should be made as follows:

in the form of a check jointly payable to petitioner and to petitioner's attorney, Muller Brazil, LLP, in the amount of **§15,250.00**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court **SHALL ENTER JUDGMENT** in accordance with the terms of the parties' stipulation.<sup>3</sup>

IT IS SO ORDERED.
