DECISION ON ATTORNEY FEES AND COSTS¹

Dorsey, Chief Special Master:

On September 12, 2014, Sheryl Cox filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² [the "Vaccine Act" or "Program"]. Petitioner alleges that she suffered Guillain-Barré syndrome ("GBS") resulting from the influenza ("flu") vaccine she received on October 1, 2013. Petition at 1, ¶¶ 2, 10. On July 2, 2015, a decision awarding compensation to petitioner based on the parties' stipulation was issued.

On September 28, 2015, the parties filed a Stipulation of Facts Regarding Final Attorneys' Fees and Costs. According to the stipulation, the parties agree upon an

award of \$16,182.76 for attorney's fees and costs. In accordance with General Order #9, petitioner's counsel represents that petitioner incurred no out-of-pocket expenses in this case. Stipulation, ¶ 3.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300 aa-15(e). The proposed amount is reasonable.

Accordingly, I award the total of \$16,182.76³ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Amber Wilson.

IT IS SO ORDERED.

³ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, 42 U.S.C. § 300aa-15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. *See generally Beck v. Sec'y, HHS*, 924 F.2d 1029 (Fed. Cir.1991).
