DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On October 3, 2014, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleged that she suffered Guillain-Barré syndrome ("GBS") as a result of an influenza ("flu") vaccine she received on October 7, 2011. On April 15, 2016, the undersigned issued a decision dismissing this case for insufficient proof. (ECF No. 29).

On June 17, 2016, petitioner filed an unopposed application for attorneys' fees and costs. (ECF No. 33).³ Petitioner requests attorneys' fees in the amount of \$16,971.70 and attorneys' costs in the amount of \$6,237.79 for a total amount of \$23,209.49. *Id.* at 1. In compliance with General Order #9, petitioner filed a signed statement indicating petitioner incurred no out-of-pocket expenses on July 15, 2016. (ECF No. 35).

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's application for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$23,209.49⁴ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel, Diana L. Stadelnikas Sedar, Esq.

The clerk of the court shall enter judgment in accordance herewith.⁵

³ In the motion, petitioner states that respondent "is unopposed to reimbursement in the amount of \$23,209.49." (ECF No. 33 at 1.)

⁴ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, § 15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. *See generally Beck v. Sec'y of Health & Human Servs.*, 924 F.2d 1029 (Fed. Cir.1991).

⁵ Pursuant to Vaccine Rule 11(a), entry of judgment can be expedited by the parties' joint filing of notice renouncing the right to seek review.
