DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On December 3, 2015, the parties filed a stipulation of fact in which they agreed on an appropriate amount for attorneys' fees and costs in this case.

In accordance with the General Order #9 requirement, petitioner asserts that she did not incur any costs in pursuit of her petition. Petitioner submitted a draft application for attorneys' fees and costs to respondent, requesting a total amount of \$10,284.96. Respondent does not object to this amount. The undersigned finds this amount to be reasonable. Accordingly, the

court awards **\$10,284.96**, representing reimbursement for attorneys' fees and costs. The award shall be in the form of a check payable jointly to petitioner and The Simon Law Firm, P.C. in the amount of **\$10,284.96**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²
