## DECISION ON ATTORNEYS' FEES AND COSTS<sup>1</sup>

Dorsey, Chief Special Master:

On May 11, 2015, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the "Vaccine Act"). Petitioner alleged that an influenza vaccine she received on November 14, 2013, caused her to develop Guillain-Barré Syndrome ("GBS"). On February 2, 2016, the undersigned issued a decision awarding compensation to petitioner based on the parties' joint stipulation.

On February 12, 2016, the parties filed a Stipulation of Fact Concerning Attorneys' Fees and Costs. According to the stipulation, the parties stipulate to an award of \$15,563.46. In accordance with General Order #9, petitioner submitted a

statement confirming that she incurred no out-of-pocket expenses in the prosecution of her petition.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300 aa-15(e). Based on the reasonableness of petitioner's request and the lack of any objection by respondent, the undersigned **<u>GRANTS</u>** the request for approval and payment of attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$15,563.46<sup>3</sup> as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel, Susan M. Cremer.

The clerk of the court shall enter judgment in accordance herewith.<sup>4</sup>
