## **RULING ON ENTITLEMENT<sup>1</sup>**

## **Dorsey**, Chief Special Master:

On May 12, 2015, Logan Osberg filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> [the "Vaccine Act" or "Program"]. Petitioner alleges that he suffered a shoulder injury related to vaccine administration (SIRVA) caused by the influenza vaccine he received in his left arm on November 13, 2014. Petition at 1. Petitioner further alleges that he continues to suffer the residual effects of his injury. *Id.*, ¶¶ 10-11. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On September 18, 2015, respondent filed her Rule 4(c) report in which she concedes that petitioner "is entitled to compensation for the left shoulder injury he sustained following his receipt of the flu vaccination on November 13, 2014." Respondent's Rule 4(c) Report at 1. "[R]espondent has concluded that petitioner's left

shoulder injury is compensable as a 'caused-in-fact' injury under the Act." *Id.* at 4. Furthermore, respondent agrees that all statutory and jurisdictional requirements have been met. *Id.* 

In view of respondent's concession and the evidence before me, I find that petitioner is entitled to compensation.
