DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On May 26, 2015, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleged that he suffered bilateral radial neuropathies, acute inflammatory demyelinating polyneuropathy ("AIDP"), possible acute motor axonal neuropathy ("AMAN") of AIDP, and/or Guillain-Barré Syndrome ("GBS") as a result of receiving the influenza ("flu") vaccine on October 11, 2014. On August 5, 2016, the undersigned issued a decision awarding compensation to petitioner based on the parties' joint stipulation. (ECF No. 32).

On August 31, 2016, petitioner filed a motion for attorneys' fees and costs. (ECF No. 36). Petitioner requests attorneys' fees in the amount of \$24,711.00 and attorneys'

costs in the amount of \$2,036.64 for a total amount of \$26,747.64. *Id.* at 1. In compliance with General Order #9, petitioner has filed a signed statement indicating that he incurred no out-of-pocket expenses. (ECF No. 30).

On September 16, 2016, respondent filed a response stating respondent has no objection to petitioner's motion. (ECF No. 40). Specifically, respondent stated that she "does not object to the overall amount sought, as it is not an unreasonable amount to have been incurred for proceedings in this case to date." *Id.* That said, her "lack of objection to the amount sought in this case should not be construed as admission, concession, or waiver as to the hourly rates requested, the number of hours billed, or the other litigation related costs." *Id.*

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$26,747.64³ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Richard H. Moeller.

The clerk of the court shall enter judgment in accordance herewith.4
