## UNPUBLISHED DECISION ON ATTORNEYS' FEES AND COSTS1

On June 18, 2015, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, et seq., (the "Vaccine Act"). Petitioner alleged that she suffered linchen planus. On August 23, 2016, the undersigned issued a decision awarding compensation to petitioner based on the parties' stipulation.

Because petitioner received compensation, petitioner is entitled to an award of attorneys' fees and costs. 42 U.S.C. § 300aa-15(e).

On February 2, 2017, petitioner filed a motion for attorneys' fees and costs; respondent filed a response not objecting to the amount sought on February 7, 2017. Petitioner requests attorneys' fees in the amount of \$16,944.50 and attorneys' costs in the amount of \$893.02 for a total amount of \$17,837.52. In accordance with General Order #9, petitioner's counsel represents that petitioner incurred no out-of-pocket expenses.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$17,837.52. Of this amount \$17,837.52 shall be payable as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Maximillian J. Muller.<sup>2</sup>

The clerk of the court shall enter judgment in accordance herewith.<sup>3</sup>
