## DECISION ON ATTORNEYS' FEES AND COSTS<sup>1</sup>

Dorsey, Chief Special Master:

On July 17, 2015, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the "Vaccine Act"). Petitioner alleged that she suffered Guillain-Barré Syndrome ("GBS") caused-infact by the trivalent influenza vaccine she received on November 19, 2012. Petition at 1, ¶ 6. On October 31, 2016, the undersigned issued a decision awarding compensation to petitioner based on the parties' stipulation. (ECF No. 38).

On March 14, 2017, petitioner filed a motion for attorneys' fees and costs, requesting attorneys' fees in the amount of **\$14,002.50** and attorneys' costs in the amount of **\$1,617.09** for a total amount of **\$15,619.59**. Petitioner's Motion for Attorneys' Fees and Costs ("Pet. Motion") (ECF No. 43). In accordance with General Order #9,

petitioner's counsel represents that petitioner incurred no out-of-pocket expenses. See Affidavit from Petitioner's Counsel, filed as 2<sup>nd</sup> Attachment to Pet. Motion (ECF No. 43-2).

On March 21, 2017, respondent filed a response stating respondent has no objection to the overall amount sought by petitioner. (ECF No. 44). Respondent adds, however, that the lack of objection "should not be construed as admission, concession, or waiver as to the hourly rates requested, the number of hours billed, or the other litigation related costs." *Id.* 

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$<u>15,619.59</u><sup>3</sup> as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Scott Kelly.

The clerk of the court shall enter judgment in accordance herewith.<sup>4</sup>
