DECISION ON ATTORNEYS' FEES AND COSTS¹

On September 1, 2015, Gene Michaelson ("petitioner") filed a petition pursuant to the National Vaccine Injury Compensation Program.² 42 U.S.C. §§ 300aa-1 to 34 (2012). Petitioner alleged that as a result of receiving an influenza ("flu") vaccination on October 9, 2014, he developed transverse myelitis ("TM"). Petition at ¶¶ 1, 7-8. On August 3, 2016, the parties filed a stipulation in which they stated that a decision should be entered awarding compensation. A decision awarding petitioner compensation pursuant to the terms of the parties' stipulation was issued August 4, 2016.

² The National Vaccine Injury Compensation Program is set forth in Part 2 of the National Childhood Vaccine Injury Act of 1986, Pub. L. No. 99-660, 100 Stat. 3755, codified as amended, 42 U.S.C. §§ 300aa-1 to -34 (2012) (Vaccine Act or the Act). All citations in this decision to individual sections of the Vaccine Act are to 42 U.S.C.A. § 300aa.

On October 11, 2016, petitioners filed an unopposed motion for attorneys' fees and costs, requesting \$26,264.70 in attorneys' fees, \$2,217.00 in attorneys' costs, and \$52.65 in petitioner's costs. Petitioner's ("Pet.") Motion ("Mot.") at 1; Pet. Ex. 17. Petitioner's motion states that "[r]espondent does not object to the payment of Petitioner's above attorneys' fees and reimbursement of Petitioner's above case costs." Pet. Mot. at 1.

The Vaccine Act permits an award of reasonable attorneys' fees and costs under 42 U.S.C. section 300aa-15(e). Based on the reasonableness of petitioners' request and the lack of objection by respondent, the undersigned **GRANTS** the request for approval and payment of attorneys' fees and costs, pursuant to 42 U.S.C. § 300 aa-15(e).

An award should be made as follows:

- (1) **A lump sum of \$28,481.70, payable jointly to petitioner and petitioner's counsel, Alison H. Haskins, of Maglio Christopher & Toale, PA, for attorneys' fees and costs.**
- (2) **A lump sum of \$52.65, payable to petitioner, for petitioner's costs.**

In the absence of a motion for review filed pursuant to RCFC Appendix B, the Clerk of the Court **SHALL ENTER JUDGMENT** in accordance herewith.³

IT IS SO ORDERED.
