DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On September 15, 2015, Diane Peschio ("petitioner") filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleged that she suffered brachial neuritis (Parsonage Turner syndrome) as a result of an influenza ("flu") vaccine she received on September 25, 2012. On July 25, 2016, the undersigned issued a decision awarding compensation to petitioner based on the parties' stipulation. (ECF No. 30).

On January 30, 2017, petitioner filed an unopposed motion for attorneys' fees and costs. (ECF No. 35). Petitioner requests attorneys' fees in the amount of \$10,182.50, attorneys' costs in the amount of \$736.45, for a total amount of \$10,918.95.

Id. at 2. In compliance with General Order #9, on March 14, 2017, petitioner filed a signed statement indicating she incurred no out-of-pocket expenses.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$10,918.95³ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Douglas & London, P.C.

The clerk of the court shall enter judgment in accordance herewith.⁴

³ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, § 15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. *See generally Beck v. Sec'y of Health & Human Servs.*, 924 F.2d 1029 (Fed. Cir.1991).
