DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On September 29, 2015, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleged that she suffered a shoulder injury caused in fact by her October 24, 2014 influenza vaccination. On January 22, 2016, the undersigned issued a decision awarding compensation to petitioner based on the respondent's proffer. (ECF No. 18).

On June 17, 2016, petitioner filed an unopposed motion for attorneys' fees and costs. (ECF No. 24). Petitioner requests attorneys' fees and costs in the amount of \$13,683.11. *Id.* at 1. In accordance with General Order #9, petitioner's counsel represents that petitioner incurred no out-of-pocket expenses in pursuit of the claim. *Id.*

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **<u>GRANTS</u>** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$13,683.11³ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Amber Wilson.⁴

The clerk of the court shall enter judgment in accordance herewith.⁵
