DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On November 13, 2015, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleged that she suffered from Guillain-Barre Syndrome ("GBS") following a November 16, 2012 influenza ("flu") vaccination. On June 28, 2016, the undersigned issued a decision awarding compensation to petitioner based on the parties' joint stipulation. (ECF No. 25).

On May 3, 2016, petitioner filed an unopposed motion for attorneys' fees and costs. (ECF No. 21). On September 16, 2016, the undersigned issued a reasoned

decision in *DiPietro v. HHS*, 15-742V, setting forth an hourly rate for petitioner's counsel, and petitioner was ordered to file an amended motion for attorneys' fees and costs including billing records reflecting that hourly rate. (ECF No. 30). Petitioner filed an amended unopposed motion for attorneys' fees and costs on October 10, 2016. (ECF No. 31).³ Petitioner requests attorneys' fees in the amount of \$17,927.00 and attorneys' costs in the amount of \$1,368.39 for a total amount of \$19,295.39. *Id.* at 1. In accordance with General Order #9, petitioner's counsel represents that petitioner incurred no out-of-pocket expenses.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$19,295.39⁴ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Leah V. Durant.

The clerk of the court shall enter judgment in accordance herewith.⁵

⁴ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, § 15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. *See generally Beck v.
