### **DECISION ON ATTORNEYS' FEES AND COSTS<sup>1</sup>**

**Dorsey**, Chief Special Master:

On November 16, 2015, Barbara J. Smith ("petitioner") filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the "Vaccine Act"). Petitioner alleged that she suffered a shoulder injury as a result of a tetanus-diphtheria-acellular pertussis ("TDaP") vaccine she received on October 10, 2014. On April 27, 2016, the undersigned issued a decision awarding compensation to petitioner based on respondent's proffer. (ECF No. 18).

On June 2, 2016, petitioner filed an amended unopposed motion for attorneys' fees and costs.<sup>3</sup> (ECF No. 21).<sup>4</sup> Petitioner requests attorneys' fees in the amount of \$5,215.00, and attorneys' costs in the amount of \$634.91, for a total amount of \$5,849.91. Pursuant to General Order #9, petitioner filed a statement stating that she incurred no out-of-pocket expenses.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

**Accordingly, the undersigned awards the total of \$5,849.91,<sup>5</sup> as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Laurie C. TeWinkle.**

The clerk of the court shall enter judgment in accordance herewith.<sup>6</sup>

<sup>3</sup> Petitioner's original motion for attorney's fees and costs filed on May 20, 2016, did not contain a statement pursuant to General Order Number 9 or a breakdown of petitioner's attorney's fees and attorney's costs.

<sup>4</sup> In the motion, petitioner states that respondent has no objection to petitioner's request.

<sup>5</sup> This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, § 15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. See *generally Beck v. Sec'y of Health & Human Servs.*, 924 F.2d 1029 (Fed. Cir.1991).

<sup>6</sup> Pursuant to Vaccine Rule 11(a), entry of judgment can be expedited by the parties' joint filing of notice renouncing the right to seek review.
