### DECISION ON ATTORNEYS' FEES AND COSTS<sup>1</sup>

Dorsey, Chief Special Master:

On November 23, 2015, Emanuel Woods ("petitioner") filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the "Vaccine Act"). Petitioner alleged that he suffered from Guillain-Barre syndrome ("GBS") as a result of an influenza ("flu") vaccine he received on November 25, 2013. Petition at 1. On June 27, 2016, the undersigned issued a decision awarding compensation to petitioner based on the parties' joint stipulation. (ECF No. 15).

On July 11, 2016, petitioner filed a motion for attorneys' fees and costs. (ECF No. 19). Petitioner requests attorneys' fees in the amount of \$18,881.50, and attorneys' costs in the amount of \$1,342.38, for a total amount of \$20,223.88. *Id.* at 1-2. In

accordance with General Order #9, petitioner's counsel states that Mr. Woods did not advance any funds in the prosecution of his claim.

On July 27, 2016, respondent filed a response to the motion for attorneys' fees and costs stating that respondent does not object to the overall amount sought, as it is not an unreasonable amount to have been incurred for the proceedings to date. Respondent states that her lack of objection should not be construed as an admission, concession or waiver as to the hourly rate requested, the number of hours billed, or the other litigation costs.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$20,223.88<sup>3</sup> as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel <u>Muller Brazil, LLP</u>.

The clerk of the court shall enter judgment in accordance herewith.<sup>4</sup>
