### **RULING ON ENTITLEMENT<sup>1</sup>**

**Dorsey**, Chief Special Master:

On January 4, 2016, Danielle Lipscomb Malone (“petitioner”) filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the “Vaccine Act”). Petitioner alleges that she received an influenza (“flu”) vaccine on November 26, 2013, and thereafter suffered from left shoulder pain which was caused-in-fact by the flu vaccine. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On April 29, 2016, respondent filed her Rule 4(c) report in which she concedes that petitioner is entitled to compensation in this case. Respondent’s Rule 4(c) Report at 1. Specifically, respondent states that “petitioner’s alleged injury is consistent with a shoulder injury related to vaccine administration (‘SIRVA’) and recommends that compensation be awarded in this case.” *Id.* at 1. Respondent further states that the six month sequela requirement has been satisfied. *Id.* at 3.
