DECISION AWARDING DAMAGES¹

Dorsey, Chief Special Master:

On January 27, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act" or "Program"). Petitioner alleged that her receipt of a Twinrix (hepatitis A and B) vaccine on February 13, 2014, caused her to suffer a shoulder injury. The case was assigned to the Special Processing Unit ("SPU") of the Office of Special Masters.

On July 8, 2016, the undersigned issued a ruling on entitlement finding petitioner entitled to compensation for SIRVA. On July 8, 2016, respondent filed a proffer on award of compensation ("Proffer") in her Rule 4(c) Report indicating petitioner should be awarded \$60,000.00. Rule 4(c) Rep. at 3. In the Proffer, respondent represented that

petitioner agrees with the proffered award. *Id.* Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the Proffer,³ **the undersigned awards petitioner a lump sum payment of \$60,000.00 in the form of a check payable to petitioner, Julie Fisk.** This amount represents compensation for all damages that would be available under § 300aa-15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.⁴

IT IS SO ORDERED.
