DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On February 2, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleged that she suffered a shoulder injury related to vaccine administration following a tetanus-diphtheria-acellular pertussis vaccine on October 13, 2014. On August 2, 2016, the undersigned issued a decision awarding compensation to petitioner based on the parties' proffer. (ECF No. 25).

On July 12, 2016, petitioner filed an unopposed motion for attorneys' fees and costs. (ECF No. 22).³ Petitioner requests attorneys' fees in the amount of \$12,965.00 and attorneys' costs in the amount of \$645.98 for a total amount of \$13,610.98. *Id.* at 1. In compliance with General Order #9, petitioner has filed a signed statement indicating petitioner incurred no out-of-pocket expenses.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$13,610.98⁴ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel John R. Howie, Jr.

The clerk of the court shall enter judgment in accordance herewith.⁵

³ The motion was filed as an unopposed motion but does not specifically state that respondent has no objection.

⁴ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, § 15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. See generally Beck v. Sec'y of Health & Human Servs., 924 F.2d 1029 (Fed. Cir.1991).

⁵ Pursuant to Vaccine Rule 11(a), entry of judgment can be expedited by the parties' joint filing of notice renouncing the right to seek review.
