## **DECISION ON ATTORNEYS' FEES AND COSTS<sup>1</sup>**

## **Dorsey, Chief Special Master:**

On March 30, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the "Vaccine Act" or "Program"). Petitioner alleged that her receipt of an influenza ("flu") vaccine on September 18, 2013, caused her to suffer a left shoulder injury related to vaccine administration ("SIRVA"). On July 8, 2016, the undersigned issued a decision awarding compensation to petitioner based on respondent's proffer to which petitioner agreed. (ECF No. 14).

On July 21, 2016, petitioner filed an unopposed motion for attorneys' fees and costs. (ECF No. 18).<sup>3</sup> Petitioner requests attorneys' fees in the amount of \$9,558.00 and attorneys' costs in the amount of \$678.86 for a total amount of \$10,236.86. *Id.* In compliance with General Order #9, petitioner has filed a signed statement indicating petitioner incurred no out-of-pocket expenses. *See* Attachment 2 to Petitioner's Unopposed Motion for Attorneys' Fees and Costs (ECF No. 18).

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$10,236.86<sup>4</sup> as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel John R. Howie, Jr.

The clerk of the court shall enter judgment in accordance herewith.5
