DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On April 4, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleged that she developed shoulder injuries as a result of a Prevnar 13 pneumococcal conjugate vaccination she received on April 16, 2015. On September 9, 2016, the undersigned issued a decision awarding compensation to petitioner based on the respondent's proffer. (ECF No. 16).

On November 30, 2016, petitioner filed a motion for attorneys' fees and costs. (ECF No. 22). Petitioner requests attorneys' fees in the amount of \$15,856.50 and attorneys' costs in the amount of \$484.31 for a total amount of \$16,340.81. *Id.* at 2. In

accordance with General Order #9, petitioner's counsel represents that petitioner incurred no out-of-pocket expenses.

On December 6, 2016, respondent filed a response to petitioner's motion. (ECF No. 23). Respondent argues that "[n]either the Vaccine Act nor Vaccine Rule 13 contemplates any role for respondent in the resolution of a request by a petitioner for an award of attorneys' fees and costs." *Id.* at 1. Respondent adds, however, that she "is satisfied the statutory requirements for an award of attorneys' fees and costs are met in this case." *Id.* at 2. Respondent respectfully recommends that the undersigned "exercise her discretion and determine a reasonable award of attorneys' fees and costs." *Id.* at 3. Petitioner did not file a reply.

The undersigned has reviewed the billing records submitted with petitioner's request. In the undersigned's experience, the request appears reasonable, and the undersigned finds no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards \$16,340.81,³ representing reimbursement for attorneys' fees and costs, in the form of a check payable jointly to petitioner and petitioner's counsel, Maximillian J. Muller.

The clerk of the court shall enter judgment in accordance herewith.4

³ This amount is intended to cover all legal expenses incurred in this matter.
