DECISION AWARDING DAMAGES¹

Dorsey, Chief Special Master:

On April 6, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleges that he suffered a shoulder injury related to vaccine administration ("SIRVA") as a result of an influenza ("flu") vaccination administered on August 28, 2014. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On July 8, 2016, a ruling on entitlement was issued, finding petitioner entitled to compensation for a SIRVA. On August 19, 2016, respondent filed a proffer on award of compensation ("Proffer") indicating petitioner should be awarded \$115,000.00. Proffer at 1. In the Proffer, respondent represented that petitioner agrees with the proffered

award. Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, the undersigned awards petitioner a lump sum payment of \$115,000.00 in the form of a check payable to petitioner, Marvin Rausch. This amount represents compensation for all damages that would be available under § 300aa-15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.³

RESPONDENT'S PROFFER ON AWARD OF COMPENSATION

In her July 8, 2016 Ruling on Entitlement, the Chief Special Master found that a preponderance of the medical evidence indicates that petitioner suffered a shoulder injury related to vaccine administration ("SIRVA"), which was causally related to the flu vaccination he received on August 28, 2014. The parties have now addressed the amount of compensation to be awarded in this case.

I. Compensation

Based upon the evidence of record, respondent proffers that petitioner should be awarded a total lump sum of \$115,000.00, which amount represents all elements of compensation to which petitioner would be entitled under 42 U.S.C. § 300aa-15(a). Petitioner agrees.

II. Form of the Award

The parties recommend that the compensation provided should be made through lump sum payment in the form of a check for \$115,000.00, payable to petitioner.
