RULING ON ENTITLEMENT¹

Dorsey, Chief Special Master:

On April 13, 2016, Rebecca S. Melgares (“petitioner”) filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the “Vaccine Act”). Petitioner alleged that she suffered a shoulder injury related to vaccine administration (“SIRVA”) as a result of an influenza (“flu”) vaccine she received on October 20, 2014. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On May 19, 2016, respondent filed her Rule 4(c) report in which she concedes that petitioner is entitled to compensation in this case. Respondent’s Rule 4(c) Report at 1. Specifically, respondent states that petitioner’s alleged injury is consistent with SIRVA. *Id.* at 3. Respondent further agrees that petitioner met the statutory requirements by suffering the condition for more than six months, and thus, petitioner has satisfied all legal prerequisites for compensation under the Vaccine Act. *Id.*
