## **DECISION ON ATTORNEYS' FEES AND COSTS<sup>1</sup>**

## **Dorsey, Chief Special Master:**

On June 6, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleges that he suffered a right shoulder injury caused in fact by the influenza vaccine he received on October 20, 2014. Petition at ¶¶ 2, 4, 14. On August 21, 2017, the undersigned issued a decision awarding compensation to petitioner based on the parties' stipulation. (ECF No. 27).

On October 11, 2017, petitioner filed a motion for attorneys' fees and costs. (ECF No. 31). Petitioner requests attorneys' fees in the amount of \$12,758.50 and attorneys' costs in the amount of \$834.65. *Id.* at ¶¶ 1-4. In accordance with General

Order #9, petitioner's counsel represents that petitioner incurred no out-of-pocket expenses. *Id.* at ¶ 4. Thus, the total amount requested is \$13,593.15.

On October 20, 2017, respondent filed a response to petitioner's motion. (ECF No. 32.) Respondent argues that "[n]either the Vaccine Act nor Vaccine Rule 13 contemplates any role for respondent in the resolution of a request by a petitioner for an award of attorneys' fees and costs." *Id.* at 1. Respondent adds, however, that he "is satisfied the statutory requirements for an award of attorneys' fees and costs are met in this case." *Id.* at 2. Respondent "respectfully recommends that the Chief Special Master exercise her discretion and determine a reasonable award for attorneys' fees and costs." *Id.* at 3.

In response to an email inquiry from the OSM staff attorney managing this SPU case, petitioner's counsel indicated petitioner did not intend to file a reply to respondent's response. See Informal Remark, dated Oct. 23, 2017.

The undersigned has reviewed the billing records submitted with petitioner's request. In the undersigned's experience, the request appears reasonable, and the undersigned finds no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$13,593.15<sup>3</sup> as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Paul Brazil.

The clerk of the court shall enter judgment in accordance herewith.4
