DECISION ON ATTORNEYS' FEES AND COSTS¹

Dorsey, Chief Special Master:

On June 14, 2016, Sophie Rose ("petitioner") filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleged that she suffered a left shoulder injury as a result of an influenza ("flu") vaccine that was administered to her on October 17, 2013. On January 6, 2017, the undersigned issued a decision awarding compensation to petitioner based on respondent's proffer. (ECF No. 26).

On March 31, 2017, petitioner filed an unopposed motion for attorneys' fees and costs. (ECF No. 30).³ Petitioner requests attorneys' fees in the amount of \$13,750.40,

and attorneys' costs in the amount of \$566.03, for a total amount of \$14,316.43. *Id.* at 1-2. In compliance with General Order #9, petitioner has filed a signed statement indicating petitioner incurred no out-of-pocket expenses.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$<u>14,316.43</u>,⁴ as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel <u>Alison H. Haskins, Esq</u>.⁵

The clerk of the court shall enter judgment in accordance herewith.⁶
