RULING ON ENTITLEMENT¹

Dorsey, Chief Special Master:

On June 23, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleges that she suffered a shoulder injury related to vaccine administration ("SIRVA") as a result of her October 10, 2013 influenza ("flu") vaccination. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On November 4, 2016, respondent filed her Rule 4(c) report in which she concedes that petitioner is entitled to compensation in this case. Respondent's Rule 4(c) Report at 1. Specifically, respondent has concluded "that petitioner's left shoulder injury is consistent with SIRVA, and that it was caused in fact by the flu vaccine she received on October 10, 2013." *Id.* at 3. Respondent further agrees that no other causes have been identified for petitioner's injury and "records show that she suffered

the sequela of her injury for more than six months." *Id.* 3-4. Accordingly, respondent states that "petitioner has met the statutory requirements for entitlement to compensation." *Id.* at 4.

In view of respondent's concession and the evidence before me, the undersigned finds that petitioner is entitled to compensation.
