RULING ON ENTITLEMENT¹

Dorsey, Chief Special Master:

On June 29, 2016, JoAnn Savage ("petitioner") filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*, ² (the "Vaccine Act" or "Program"). Petitioner alleges that she suffered shoulder injuries as a result of an influenza ("flu") vaccination received on September 1, 2015. Pet. at 1. The case was assigned to the Special Processing Unit ("SPU") of the Office of Special Masters.

On October 7, 2016, respondent filed a Rule 4(c) Report in which she concedes that petitioner is entitled to compensation in this case. Rule 4(c) Rep. at 1. Specifically, respondent stated that the evidence establishes that petitioner's injury is consistent with a shoulder injury related to vaccine administration ("SIRVA"), and that the injury was caused-in-fact by her flu vaccination on September 1, 2015. *Id.* at 5-6. Additionally,

respondent stated that no other causes for petitioner's SIRVA were identified, and that all statutory and jurisdictional requirements have been met, including having suffered the condition for more than six months. *Id.* at 5. Thus, respondent concludes that entitlement to compensation is appropriate under the terms of the Vaccine Act. *Id.*

In view of respondent's concession and the evidence of record, the undersigned finds that petitioner is entitled to compensation.

IT IS SO ORDERED.
