## ORDER CONCLUDING PROCEEDINGS<sup>1</sup>

On July 11, 2016, Connor Toes ("Petitioner") filed a petition for compensation under the National Childhood Vaccine Injury Act of 1986, 42 U.S.C. §§ 300aa-1 to -34 (2012).<sup>2</sup> Petitioner alleged that the administration of Gardasil, varicella, and Menactra vaccines in July of 2013 caused him to develop hypothyroidism, autonomic neuropathy, and chronic fatigue. Petition, ECF No. 1.

On November 9, 2017, Petitioner and Respondent submitted a joint Stipulation of Dismissal. Stip., ECF No. 44. Accordingly, pursuant to Vaccine Rule 21(a), the above-captioned case is hereby **dismissed without prejudice**. The Clerk of the Court is hereby instructed that a **judgment shall not enter** in the instant case pursuant to Vaccine Rule 21(a).
