### DECISION ON ATTORNEYS' FEES AND COSTS<sup>1</sup>

Dorsey, Chief Special Master:

On July 18, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the "Vaccine Act"). Petitioner alleged that she suffered from Guillain-Barre Syndrome that was cased by an influenza vaccination she received on January 31, 2014. On January 31, 2017, the undersigned issued a decision awarding compensation to petitioner based on parties' joint stipulation. (ECF No. 16).

On March 22, 2017, petitioner filed a motion for attorneys' fees and costs. (ECF No. 20). Petitioner requests attorneys' fees in the amount of \$12,484.50 and attorneys'

costs in the amount of \$1,016.18 for a total amount of \$13,500.68. *Id.* at 2. In compliance with General Order #9, petitioner has filed a signed statement indicating petitioner incurred no out-of-pocket expenses.

On April 6, 2017, respondent filed a response stating respondent does not object to the overall amount sought. (ECF No. 21).

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's motion for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$13,500.68<sup>3</sup> as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel Jeffrey S. Pop.

The clerk of the court shall enter judgment in accordance herewith.<sup>4</sup>
