#### **DECISION AWARDING DAMAGES**<sup>1</sup>

## **Dorsey**, Chief Special Master:

On July 27, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the "Vaccine Act"). Petitioner alleges that she suffered a right shoulder injury related to vaccine administration ("SIRVA"), which was caused-in-fact by an influenza ("flu") vaccination. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On January 3, 2017, a ruling on entitlement was issued, finding petitioner entitled to compensation for a SIRVA. On April 28, 2017, respondent filed a proffer on award of compensation ("Proffer") indicating petitioner should be awarded \$154,742.57. Proffer at 1. In the Proffer, respondent represented that petitioner agrees with the proffered

award. Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, the undersigned awards petitioner a lump sum payment of \$154,742.57 in the form of a check payable to petitioner, Lisa Webb. This amount represents compensation for all damages that would be available under § 300aa-15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.<sup>3</sup>

#### RESPONDENT'S PROFFER ON AWARD OF COMPENSATION

On July 27, 2016, Lisa Webb ("petitioner") filed a petition for vaccine injury compensation alleging that she suffered a right shoulder injury related to vaccine administration ("SIRVA"), which was caused-in-fact by an influenza ("flu") vaccination administered on November 7, 2014. Respondent filed his Rule 4(c) Report conceding entitlement to compensation on January 3, 2017. The Chief Special Master issued a Ruling on Entitlement on January 4, 2017.

### I. <u>Items of Compensation</u>

Based upon the evidence of record, respondent proffers that petitioner should be awarded \$154,742.57, which represents all elements of compensation to which petitioner would be entitled under 42 U.S.C. § 300aa-15(a). Petitioner agrees.

#### II. Form of the Award

The parties recommend that the compensation provided to petitioner should be made through a lump sum payment of \$154,742.57 in the form of a check payable to petitioner.<sup>2</sup> Petitioner agrees.
