## **RULING ON ENTITLEMENT<sup>1</sup>**

## **Dorsey**, Chief Special Master:

On August 9, 2016, Susan Cobbina ("petitioner") filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*, 2 (the "Vaccine Act"). Petitioner alleges that she suffered a right shoulder injury, including right shoulder cuff bursitis, as a result of an influenza ("flu") vaccine she received on December 5, 2015. Petition at 1-2. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On October 24, 2016, respondent filed her Rule 4(c) report in which she concedes that petitioner is entitled to compensation in this case. Respondent's Rule 4(c) Report at 1. Specifically, respondent states that "petitioner's alleged injury is consistent with a shoulder injury related to vaccine administration ('SIRVA'), and it was caused by the flu vaccination that petitioner received on December 5, 2015. *Id.* at 5.

Respondent further agrees that no other causes were identified for petitioner's shoulder injury and the medical records show that petitioner suffered the residual effects of her injury for more than six months. *Id.* at 5-6.

In view of respondent's concession and the evidence before me, the undersigned finds that petitioner is entitled to compensation.
