RULING ON ENTITLEMENT¹

Dorsey, Chief Special Master:

On September 26, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, et seq.,² (the "Vaccine Act"). Petitioner alleges that he received an influenza ("flu") vaccine on October 21, 2015, and subsequently suffered a shoulder injury related to vaccine administration ("SIRVA"). Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On April 28, 2017, respondent filed his Rule 4(c) report in which he concedes that petitioner is entitled to compensation in this case. Respondent's Rule 4(c) Report at 1. Specifically, respondent concluded that petitioner's alleged injury is consistent with a SIRVA, and that a preponderance of evidence establishes that his SIRVA was caused in fact by the flu vaccine he received on October 21, 2015. *Id.* at 3. Respondent further

agrees that petitioner has met the statutory requirements for entitlement to compensation. *Id.*

In view of respondent's concession and the evidence before me, the undersigned finds that petitioner is entitled to compensation.
