# DECISION ON ATTORNEYS' FEES AND COSTS<sup>1</sup>

Dorsey, Chief Special Master:

On October 21, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the "Vaccine Act"). Petitioner alleged that she suffered a shoulder injury related to vaccine administration (SIRVA) and adhesive capsulitis as a result of her November 20, 2015 Prevnar 13 (pneumococcal conjugate) vaccination. On April 17, 2017, the undersigned issued a decision awarding compensation to petitioner based on respondent's Proffer. (ECF No. 20).

On April 19, 2017, petitioner filed an application for attorneys' fees and costs. (ECF No. 24). Petitioner requests attorneys' fees in the amount of \$12,268.00 and attorneys' costs in the amount of \$542.22 for a total amount of \$12,810.22. *Id.* at 1. In compliance with General Order #9, petitioner has filed a signed statement indicating petitioner incurred no out-of-pocket expenses.

On April 19, 2017, respondent filed a response stating

[r]espondent does not object to the overall amount sought, as it is not an unreasonable amount to have been incurred for proceedings in this case to date. Respondent's lack of objection to the amount sought in this case should not be construed as admission, concession, or waiver as to the hourly rates requested, the number of hours billed, or the other litigation related costs.

(ECF No. 25).

The Vaccine Act permits an award of reasonable attorneys' fees and costs. § 15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's application for attorneys' fees and costs.

Accordingly, the undersigned awards the total of \$12,810.22<sup>3</sup> as a lump sum in the form of a check jointly payable to petitioner and petitioner's counsel, John Robert Howie, Jr.

The clerk of the court shall enter judgment in accordance herewith.<sup>4</sup>
