RULING ON ENTITLEMENT¹

Dorsey, Chief Special Master:

On November 8, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleges that he suffered a left shoulder injury as a result of his October 17, 2015 influenza ("flu") vaccination. Petition at 1-2. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On July 10, 2017, respondent filed his Rule 4(c) report in which he concedes that petitioner is entitled to compensation in this case. Respondent's Rule 4(c) Report at 1.

Specifically, respondent

has determined that petitioner's left shoulder injury is consistent with [Shoulder Injury Related to Vaccine Administration] SIRVA, and that it was caused-in-fact by the flu vaccine he received on October 17, 2015. DICP did not identify any other causes for petitioner's SIRVA, and records show that he suffered the sequela of his injury for more than six months. Based on the medical records outlined above, petitioner has met the statutory requirements for entitlement to compensation.

Id. at 3-4.

In view of respondent's position and the evidence of record, the undersigned finds that petitioner is entitled to compensation.
